Cantor's Driving School (PA) Policies

The following terms and conditions apply to driver training services offered by Cantor's Driving School in Pennsylvania. By using our services, you are accepting these terms and conditions.

Learners Permit

Student must hold a current, valid learner's permit and present it at the beginning of each scheduled lesson. Copies will not be accepted. If a student does not have the learner's permit ready at the beginning of the lesson or it is expired, the instructor must refuse to allow the student to drive Cantor's driver training car. Should this happen, you are still obligated to pay for the lesson.

Payments and Cancellation Policy

Lesson and Package fees are due in advance or when scheduling. Payments can be made online through the Cantor's Driving School (PA) website via (credit card) or over the phone (Visa, MasterCard, Discover Only). Checks are not accepted. Cash payments can be may be made with arrangements in advance.

If you need to cancel or reschedule a lesson, you must provide at least 48 hours advance notice via email to CantorsDrivingPA@gmail.com or 610-277-1050. If you cancel a lesson within 48 hours of the scheduled start time, you are subject to a \$75 charge.

Your instructor will do everything possible to ensure your lessons start and finish on time. But we reserve the right to cancel, postpone or change lesson lengths and start/finish times under certain circumstances such as dangerous weather conditions, etc. In the event of postponement, we will reschedule the lesson or the remaining time will be carried forward to another lesson.

The instructor reserves the right to cancel a lesson on short notice if it is suspected to that student may be unfit due to effects of alcohol, drugs (prescribed or otherwise) or any other condition that would cause his/her driving to be dangerous or illegal. In such circumstances the lesson will be forfeited and there is no refund.

No Show Policy

An instructor will do his/her best to wait for a student at a designated location up to 15 minutes after the scheduled lesson start time. If the student fails to show then the entire lesson will be a forfeit and the \$75 no-show charge is payable. If the student arrives within the 15 minutes, the lesson will start and that late time will not be made up.

Scheduling and Lesson Duration

The normal lesson is two hours, beginning when the instructor arrives at the location. If, for any reason the instructor is late for the lesson, he/she will make a concerted effort to inform the pupil of the estimated time of arrival. If the delay is greater than 15 minutes this time will be credited to the student and when possible the lesson will be extended by the time due; if this is not possible the extra time will be carried forward to the next suitable lesson.

Training Locations

The instructor will determine a location for lessons based on experience of the student. When necessary the instructor may need to drive the student to and from a predetermined location. This journey time forms part of the paid lesson.

Training Vehicles

All training vehicles utilized by Cantor's Driving School are registered with the Pennsylvania Department of Education and meet all requirements for driver training vehicles. They are covered by commercial insurance, fitted with dual controls and meet all safety standards for driver training.

Drivers Test Scheduling

Scheduling is over the phone in advance of the test appointment with the Pennsylvania Department of Transportation (PennDOT). PennDOT sets the available test dates and the number of available appointments. We do our best to schedule your test for the date and time verbally requested (in advance) but at times this test date/time/location may be altered due to PennDOT availability and instructor availability. We will inform you of any such change. If the appointment time changes we may request to meet you at the PennDOT driver's test location to allot enough time to practice and be on time for the appointment.

Accompany Students to the Drivers Exam

Cantor's Driving School and your instructor are not responsible for test appointments cancelled by the PennDOT due to bad weather, sickness, staff shortages or other reasons. Such cancellations are beyond the control of Cantor's Driving School and your instructor. If the appointment is cancelled by the PennDOT, there a \$50 charge to return you to your location to cover the instructor's time.

South Chester County Residents

Due to the long distance to the nearest Pennsylvania Department of Motor Vehicles (DMV) Drivers Test Center(s), residents of south Chester County - south of US Route 1 and west of PA Route 52 - will be charged an additional \$80 per trip to cover the extra time to travel to and from the Test Center. This could be for the Day-of-Test Service and/or a practice lesson at the Test Center. This south Chester County area includes Avondale, Kennett Square, Landenberg, Lincoln University, New London, Oxford, Toughkenamon, and West Grove. If affected, Cantor's Driving School will contact you to collect the additional fee.
